They were told rezoning would not be required yet the RDC has begun rezoning process. The 2002 county master plan limits industrial growth. She asks for robust and strong council engagement to help guide going forward for consistency and small community values. She thanked Dan Caruso for representing New Carlisle at the Area Plan Commission and for asking very good questions.

Dan Caruso

Reports that he found his first APC meeting enlightening and that he was also able to appoint himself to BZA. After what we heard on Tuesday about mess down here on Michigan Street, Dave Thomas spoke out very strongly for us and called the property the swamp and that he and Commissioner Kostielney were cutting each other off while speaking. Dan stated that after witnessing how Kostielney appears to be in the pockets of NICTD, the Antero group is behind all of them and he doesn't think they are going away and will take whatever land they want to. He stated that Bill Schalliol said it is premature to know what they will do with the land and they are just cleaning up an eyesore with the trailer park at this point. One agenda item was the purchase of 150 acres for a new county garage and fire station. Dan said that he is very anxious to hear the new statement of the Council on the IEC and feels that it can't come soon enough.
