Approval of Minutes

A motion to accept the minutes of the November 19, 2019 General Meeting Minutes as written was made by Council Member Kauffman and seconded by Council Member Rush. The motion passed 3-0.

Visitor Comments

Debra DuRall

Bob Humbarger could not be here so she is sharing some of the info he presented to the County Council for him. They have knocked on over 200 doors, not including the many residents within the Town that were surveyed. All of those results were compiled and presented at the County Council meeting. Those results showed that 80 percent of those polled are against the IEC, 15 percent were not aware of the IEC and 5 percent were in favor of the IEC.

Council Member Budreau entered the meeting

Debra reported that the OSAA group is drafting resolutions to ensure oversight and more public involvement that will be made available at the next meeting.

Judy Rubleske

Judy read Caleb Bauer's article that was recently published in the SB Tribune regarding the IEC development. She feels that the word activist used in the article is a pretty general term and stressed that the supporters in attendance were all St. Joseph County residents with some from NC, Olive Twp. and surrounding areas but all within SJC. Over 100 supporters of the OSAA and others were in attendance to oppose the development of the industrial complex being proposed east of Town.

Attorney Andrea Halpin

Andrea reports that regarding the bill received from Olive Township for attorney fees that she was asked to look into, she spoke with their attorney and found that three of the charges were directly related to the territory. The remaining two are not related to the territory and should not be the Town's responsibility.

She received information from President Carter regarding new recommendations for fire prevention and building inspection. These two have been combined and will require a new ordinance that covers everything relative to fire and building. Andrea will contact the Dept. of Homeland Security directly as this will be a long project and she needs further clarification. President Carter is not certain who should be responsible for fees relating to this since we are switching to a fire territory Jan. 1. Andrea had previously been asked to look into how fees can be charged for emergency services in the TIF district since Olive Twp. is not allowed to do so by state statute. She found that this is something that can be incorporated into the annual interlocal agreements and is something that the territory must agree to abide to.

Public Works Director John Mrozinski

John gave kudos to the town crew on lights downtown as it all looks pretty good. The parade went well from his understanding. Leaf pick-up ends on the $11^{\rm th}$ and after that point they must be bagged. The new sign at Memorial Park will be taken down because it is taking on water and he will be returning it to Sign Crafters to get it sealed.
