#### **New Business**

March for Climate Change Special Event Permit

This group of approximately 15 people is marching from LA to Washington DC. They are requesting a variance to allow them to spend the night at Bourissa Hills Park. They will not require any facilities.

Council Member Vojtko moved to allow an overnight camp at Bourissa Hills Park for the Great March for Climate Action group on Thursday, September 11, 2014. The motion was seconded by Council Member Carter and passed 4-0.

### **Council Reports**

#### Council Member Carter

He and Bob Middlebrook recently attended the IACT Abandoned Property Seminar in Indy that was quite interesting and brought everyone up to date on new law changes and ideas to deal with blighted areas.

Council Member Carter thanked everyone that was involved in the ceremony to honor Jamie Middlebrook. He felt that some of the outside police agencies were very impressed by the town and its citizens opening their heart.

# Vice President Higgins

Vice President Higgins thanked John and the town employees who worked so hard to make the cemetery so beautiful for the ceremony.

She and President Colpitts met with a representative from Tejas Tubular recently. They spoke about the map hanging in the Council Room and have come to an agreement with Marcy Kauffman on restoration.

Attorney Chuck Leone is working on cemetery ownership, rules and regulations at the request of the Cemetery Board.

### Council Member Vojtko

Council Member Vojtko expressed his gratitude and appreciation for Jamie Middlebrook and all that he did for our community through the ambulance and fire departments. The entire community pulled together to help their family and each other and showed the character of the town.

There is an Area Plan meeting next week but nothing involving New Carlisle

The first Concert in the Park was rescheduled to September 1<sup>st</sup>.

Council Member Vojtko would like the council to review emergency procedures within the town and see what worked and what didn't and review changes may need to be made.

President Colpitts concurs as there must be a way to disseminate information to everyone and feels this needs to be made a part of our own internal plan.

Vice President Higgins stated that she distinctly remembers directing an employee to prepare an emergency plan two years ago.

Council Member Vojtko acknowledged the Clerk's Office for assisting with the services for Jamie.

### **President Colpitts**

Attorney Chuck Leone has recommended that we acknowledge the town manager contract with changes.

Vice President Higgins moved that the contract be ratified with the changes made. The motion was seconded by Council Member Vojtko and passed 4-0.

Unfortunately three large trees in the tree lawn at Memorial Park had to be removed as they were encroaching on the sidewalk with two of them dying. President Colpitts announced that Jill applied through IACT for trees and the Town was selected to receive three trees that will replace those trees removed for the sidewalk project.

A letter received from Sen. Arnold expressing his condolences on the loss of Jamie Middlebrook was read.
