- Vice President Doll
  - -Cemetery meeting today. He stated that Perry Hinton mentioned the clean-up went well. ---
  - -April 23<sup>rd</sup> will be a meeting to walk through and select a few stones that need to be refurbished. The board has appropriated \$10,000 for this project, so depending on the cost will determine how many will be completed.
  - -Perry asked the Cemetery board to spend approximately \$300 for sod in the areas where they can not get grass to grow.
  - -Also mentioned that Julie Brown, Clerk-Treasurer, approached him about the plat maps of the cemetery, which are starting to crumble and wants to get them digitized, which will help print out locations of sites for anyone that needs them. The old plat maps can be shadow boxed for historical value. Julie will start getting quotes to have that done.
- Council Member Colanese
  - -Fire: was approached by one of the new businesses coming into the IEC wanting to finance a Fire Marshall for the town so there will be someone to regulate some of things going on.

There should be no expense to the town and may help us with our fire inspections. The Fire Territory lawyer has been contacted and he is working on it.
